ACKNOWLEDGEMENT OF INHERENT RISKS, WAIVER, RELEASE OF ALL CLAIMS AND HOLD HARMLESS AGREEMENT FOR TRANSPORTATION TO AND FROM CURRENTS WATER PARK, A FACILITY OWNED AND OPERATED BY THE CITY OF MISSOULA PARKS AND RECREATION DEPARTMENT.

PLEASE READ THIS FORM CAREFULLY, and be aware that, by signing this form you are allowing Currents Water Park staff to transport your child or yourself to and from the water park and you are waiving and releasing the City of Missoula from all claims for injuries that you or the other named participant might sustain. The terms "I", "me", and "my" also refer to parents or guardians as well as participants in the programs. In registering for this transportation, you are acknowledging and agreeing as follows:

Automobile accidents do occur and sometimes cannot be avoided.

Children who are under 60 lbs and under age 6 are required to provide their own car seat/booster seat or they will not be allowed to ride.

All individuals over 60 lbs and over age 6 are required to be seated and belted prior to embarking.

All individuals must follow all instructions and guidelines posted or given by the driver, and must act in a safe and responsible manner at all times while riding in the vehicle. Currents Water Park is providing transportation only. While awaiting pick up, once at the facility, and after drop off, children must be supervised by the designated staff member of the program that has requested the transportation (i.e. school, pre-school, day care, after school program, etc.).

By signing this document, I am confirming that I fully understand and assume the responsibilities and risks as outlined above. In addition:

I give permission for the City of Missoula personnel to seek emergency medical services for me should I become injured or ill during transport with the understanding that I am responsible for any expenses incurred. I fully understand that the City of Missoula does NOT provide any medical insurance coverage for me during transport. I also realize that I may be attended by City of Missoula personnel until medical care is available.

I, do hereby for myself, my heirs, executors, administrators, successors, and assigns, release, acquit, and forever discharge the City of Missoula, its employees, elected officials, and insurers from any and every claim, demand, right, or cause of action, property damage, personal injury, costs, loss of service, expenses of any kind, and any compensation whatsoever, which I may ever assert by reason of my or my child's presence and/or participation and/or transportation in THE CITY OF MISSOULA van or vehicle, including any claims which might arise from natural, environmental, or weather conditions.

I hereby authorize the City of Missoula to use my likeness or picture, or that of my child, in any photograph or advertising for promotion of the Parks and Recreation Programs. I hereby acknowledge that this release is voluntarily given with full knowledge of the meaning and consequences of this release.

I have read the above provisions above and fully understand the purpose. I willingly sign below and represent that I am 18 years of age or older and otherwise competent to execute this document, or that my legal guardian is also signing this document.
